# **DUNSYRE HOUSE**

Following the handing in of a petition to the District Housing Department, signed by 106 residents of Dunsyre House, Calder . . . . last December, there has now been some movement by the District Council's Housing Committee.

Regional Councillor John Mulvey took up the tenant's case when they forwarded a copy of their petitions to him. On March 4th, the District Council's Housing Sub-Committee discussed a report from the Director of Housing. The outcome of this discussion is that a caretaker will be installed in Dunsyre House when appropriate housing becomes available. In view of the difficulties which tenants experience in transferring out of high rise blocks, "appropriate housing" becoming available could take some time.

Councillor Mulvey told the Sentinel, "the tenants in Dunsyre House were asking for action on vandalism, fire, damp, and a broken lift. I was particularly concerned about the broken lift, following the experience of a tenant in one of the blocks of flats in Westburn. It appears that her young child had managed to hit the button for the lift on the seventh floor, and when the lift door opened, the

lift was in fact on the ground floor.
I am not at all satisfied with the decision




